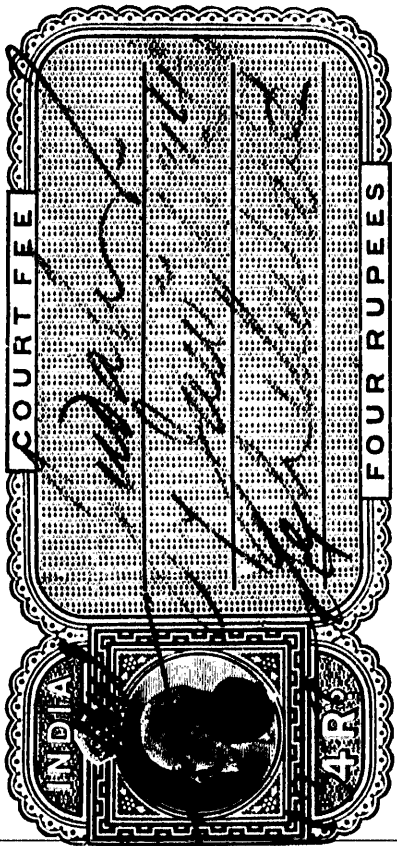
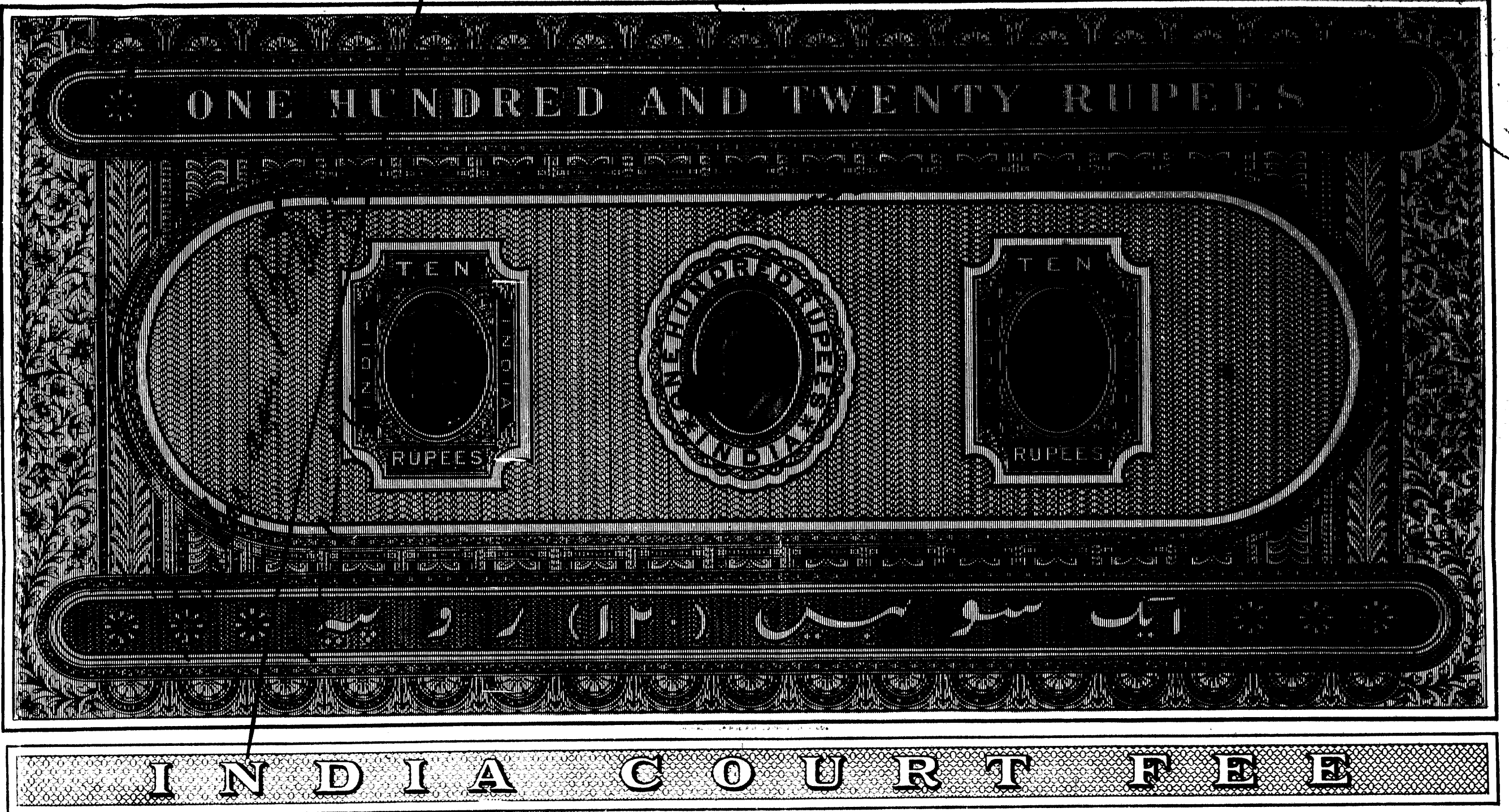

I give and bequeath to my husband the said Munsoor Solomon for his  
absolute use and benefit my house at Aden bearing grant No. 94 which was  
conveyed to me by a Deed of gift by my mother Hannah dated the 23rd day  
of December 1881.

I also give and bequeath any other property both movable and --  
immovable which I may die possessed of or entitled to at my death to my  
said husband Munsoor Solomon.

I direct my executor to pay out of my property Rupees Ten (Rs. 10/-)  
each to my son Solomon and daughter Hannah.
